DRS Directors Update

Kathy Hayfield reported that categories 1, 2 & 3 are open. Prior to April 1, 2016 there were 1000 people on the waiting list and as of today there are approximately 576 people on the waiting list. The agencies goal is to keep MSD - Category 1 open.

Overall expenditures have been down this FY compared to last FY at the same time. Expenditures with ESOs continue to be about 65% of all expenditures in case services.

We have 1700 Successful closures to date for this performance year. At this point in time we can project that we will have 3600 successful closures. Our goal is 4000.

Current average hourly wages are \$10.06 per hour. However average wages for clients employed through services with ESOs is \$8.50. WIOA changes how hourly wages are reported. We will now be reporting on the median hourly wage rather that the average hourly wage.

We will not be recommending a rate freeze for FY 2017.

Waiver Updates:

Heather Norton updated the group to the current status of the Waiver redesign.

Legislative Updates

APSE – Dan Reichard reported that APSE had several items of interest this session LTEES Increase, SAME, Waiver Redesign and Project SEARCH. LTESS funds were increased by \$375,000 beginning in FY 2017.

Virginia Goodwill Network - No report

vaACCSES – April Pinch Keeler reported that updated SWaM Legislation passed making DARS ESOs eligible to compete in the state system; Waiver Redesign - Worked to stop come of the changes and Delay some others. Worked on ensuring Community Engagement remained; LTESS Increase

Staff Updates - Donna Bonessi reported a few staff changes in the DRS-Support team. Cathy Staggs is the new LTESS/EES Support Specialist and Matthew Deans has rejoined the field in the Chesterfield office.

David Leon DARS reported; DARS no longer will allow WIPA project staff to bill for WISA services. We will continue to participate/purchase in WISA Services. Staff associated with WIPA Project are no longer on the WISA List. This change is being modeled on other states. We spent \$500,000 on WISA service. Although DARS is longer able to sponsor WISA training, Virginia organizations are still able to utilize a discount for the training.
